Prior to joining JAMS, Mr. Birke was associate director of the Stanford Center on Conflict and Negotiation and a lecturer in law at Stanford Law School. He was also a law professor at Willamette University and director of its Center for Dispute Resolution. Among other roles, Mr. Birke served as a consultant, trainer and mediator for the Oregon Court of Appeals Settlement Program; trainer and training designer for the California Courts of Appeal settlement programs (First, Second and Third districts); and assistant district attorney for the Middlesex County District Attorney's Office in Massachusetts.

In addition to his teaching and writing, Mr. Birke is an active mediator, trainer and facilitator. He has worked with state and federal agencies, multinational corporations, school systems, law firms, charities and international dispute resolution providers. As a mediator, he has settled everything from two-party partnership disputes to disputes involving thousands of acres of public land with dozens of stakeholders and hundreds of participants.

Mr. Birke's academic specialties are decision-making in law, business, government, medicine and consumer choice. He incorporates insights from ADR, psychology, economics, law, game theory, interpersonal communications, cross-cultural competency, dispute systems design, negotiation analysis and neuroscience into every aspect of his teaching, writing and training.

#### **Career ADR Experience**

Mr. Birke has been teaching dispute resolution since 1992, first at Stanford Law School and then at Willamette University College of Law, directing the Center for Dispute Resolution (CDR). Under his leadership, the CDR enjoyed a top-five national ranking among academic dispute resolution centers in the U.S.

Mr. Birke is a two-time award-winning author in the field of dispute resolution and is deeply involved in the practice of ADR.

#### **Training and Speaking Engagements**

Mr. Birke has lectured and taught in substantive fields as varied as family, criminal, environmental, commercial and banking law. He has trained individuals from a prestigious list of firms and organizations, and has given lectures at Harvard University, Stanford University, Northwestern University, UCLA, Hamline University, the University of Oregon, the University of Washington, the University of Chicago, the University of Arizona, Marquette University, Duke University, Oregon Health & Science University and elsewhere.

Mr. Birke has been involved in the hands-on resolution of complex disputes for more than 30 years. Clients have included governmental entities at the local, state and national levels; academic institutions, from high schools to graduate schools; medical institutions; and a wide variety of businesses. He generally assembles and oversees interdisciplinary and diverse teams of talented colleagues, providing clients with a cross-section of expertise. He has been involved in the largest civil rights case in U.S. history, the resolution of the largest fire catastrophe in the nation, preservation of natural areas, prisoners' rights cases, and national and international energy company issues, among others.
